Dear Mr. Ten Freyhaus,

We confirm that cover is granted for the carriage of goods with places of taking over and delivery in the Federal Republic of Germany according to the stipulations of the Commercial Code (here: Freight Contract Section §§ 407-450 HGB). Under these terms a standard liability applies of 8.33 Special Drawing Rights (SDR) of the International Monetary Fund, approx. 10 euro per kg gross weight of the concerned fraction of the shipment. Your liability is covered up to a limit of liability of 40 SDR with a sum insured of up to 1,250,000 euro per case of loss. Please note, that a deviation from the standard liability between 2 and 40 SDR requires a legally binding agreement with the principal.

For the cross-border carriage of goods cover is granted for the carrier's liability according to the international CMR convention up to the limit of liability of 8.33 SDR per kg gross weight.

A sum insured is agreed of 2,000,000 euro per event of loss with a maximum of 4,000,000 euro for all cases of loss per year.
